

**RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF
PASCO COUNTY, FLORIDA, AUTHORIZING THE OPERATION OF
GOLF CARTS WITHIN LAKE PADGETT ESTATES, PURSUANT TO
CHAPTER 316, FLORIDA STATUTES**

WHEREAS, Section 316.212(1), Florida Statutes, provides that the Board of County Commissioners shall have the authority to designate certain roads or streets within its jurisdiction for lawful operation of golf carts, subject to certain findings and such restrictions and conditions as the Board deems necessary to ensure public safety; and

WHEREAS, the Board of County Commissioners has determined that, provided such use is implemented consistent with this Resolution, golf carts may travel safely on certain designated roadways and streets within Lake Padgett Estates.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pasco County, Florida, in regular session, duly assembled, as follows:


1. The above recitals are adopted as specific findings by the Board and are incorporated by reference and made a part of this Resolution.
2. The streets and roadways on which golf carts are permitted are those local streets and roadways within the boundaries of Lake Padgett Estates, as depicted on TR18-0419 Location Map attached hereto and incorporated herein by reference ("Permitted Roads"). For all purposes in this Resolution, the terms "street" and "roadway" are used interchangeably, and shall have the meanings ascribed to them in Chapter 316, Florida Statutes. The Permitted Roads do not include any sidewalks, trails or multi-use paths within Lake Padgett Estates, and do not include any streets, roads, sidewalks, trails or multi-use paths lying within the right-of-way of Bell Lake Road or Collier Parkway unless golf cart use on such facilities is specifically permitted by a separate future Resolution of the Board of County Commissioners. As used herein, the term "golf cart" shall be as defined in Section 316.003(26), Florida Statutes.
3. Pursuant to Section 316.212(1), Florida Statutes, this designation shall be effective upon installation of the appropriate traffic control devices indicating that golf cart use is allowed on all Permitted Roads.
4. With respect to golf cart use on a Permitted Road, all golf carts must be equipped with efficient brakes, reliable steering apparatus, safe tires, a rearview mirror, and red reflectorized warning devices in both the front and rear, pursuant to Section 316.212(6), Florida Statutes, and shall only be operated on any public roads or public streets by a person age 14 years or older, pursuant to Section 316.212(7), Florida Statutes. The Board has determined that, due to the specific design, speed, and traffic volume on the Permitted Roads in Lake Padgett Estates, golf carts may be operated on the Permitted Roads between sunset and sunrise provided that such golf carts are equipped with headlights, brake lights, turn signals, and a windshield, pursuant to Section 316.212(5), Florida Statutes.
5. The posted speed limit on all Permitted Roads shall not exceed 35 miles per hour.

6. This Resolution shall take effect immediately upon its adoption.
